ACTION TAKEN REPORT ON IMPLEMENTATION OF IDOL IMMERSION GUIDELINES IN MIZORAM FOR THE YEAR 2024

1. CIRCULATION OF GUIDELINES ON IDOL IMMERSION FOR AWARENES CAMPAIGNS & SAFE IDOL IMMERSION

Mizoram Pollution Control Board circulated Revised Guidelines on Idol Immersion published by CPCB on 12th May 2020 for awareness and safe Idol Immersion to various Hindu Community such as Central Gorkha Mandir Committee and Hindustan Club, Aizawl, Mizoram, Project Pushpak, Thuampui Aizawl, 2nd Assam Rifles, Zodin Square, Aizawl, Assam Rifles 23 Sector (HQ), Khatla, Aizawl vide its letter No. H.88088/Poltn/105/24-MPCB/20 dt. 05.09.2024 requesting them to strictly adhere to the Guidelines and to submit detail information on their scheduled puja celebration programme 2024 (Ganesh Puja and Durga Puja) to Mizoram Pollution Control Board. Copy of the guidelines was also forwarded to them. (Copy of the letter is enclosed at **Annexure-I**).

Further, Deputy Commissioner, Aizawl District and Aizawl Municipal Corporation was requested to go through the Guidelines and take further necessary action for compliance of the guidelines in celebration of the upcoming Durga Puja, 2024 and to submit the action taken report (if any) before the end of October 2024 vide letter No. H.88088/Poltn/ 105/24-MPCB/159 dt. 05.09.2024 (Copy enclosed at Annexure-II (a) & (b)).

In response, Camp Commanadant, Project Pushpak, Thuampui, Aizawl vide letter No. 74040/Gen/23/E-1 Camp dt. 12.09.2024 reported to the Board that two (2) bio-degradable Idols will be immersed in Tuirial River on 17th September 2024 at 18:00 hrs for obdervation of Ganesh Puja 2024 (Copy enclosed at **Annexure-III (a)**). Secretary, Hindustan Club also submitted letter to the Board vide letter No. Nil dt 12.09.2024 and stated that permanent idol is put in their Temple and immersion activities performed by Hindustan Club is done only symbolically by immersing the offering of flowers etc which are biodegradable and non-polluting in nature. The Hindustan Club also invited the Board's official to join them on the celebration of Durga Puja on 12th October 2024. (Copy enclosed at **Annexure-III (b)**). Lt. Colonel Second-in-Command for Commandant, 2 Assam Rifles, Aizawl also reported that the unit will organize Ganesh Chaturthi Puja on 17th September 2024 and the Idol immersion will be done on 18th September 2024 at Tuirial River vide letter No. VIII.11011/PRI-Bn/2024 18.09.2024. (Copy enclosed at **Annexure-III (c)**).

Further, Chairman, Central Gorkha Mandir vide its letter No. Nil dt. Nil reported to the Board that the community recognized the importance of adhering to the CPCB's guidelines for idol immersion and as such, only biodegradable materials will be used for Iodl making and all worship materials will be removed before Iodl immersion. (Copy enclosed at **Annexure-III(d)**).

The Board also received a letter from Camp Commanadant, Project Pushpak, Thuampui, Aizawl vide letter No. 74040/Gen/33/E-1 Camp dt. 04.10.2024 and stated that Shri Durga Puja is to be organized by Headquarters Project Pushpak at Hari Mandir, Thuampui from 3rd October to 13 october 2024 and the idols will be immersed on 13th October 2024@ 15:00 hrs at Tuirial River (Copy enclosed at **Annexure-III(e)**). Lt. Colonel Second-in-Command for Commandant, 2 Assam Rifles, Aizawl vide letter No. VIII.11011/PRI-Bn (Misc)/2024/061 05.10.2024 also informed the Board that the unit will immerse the Idol of Durga Puja on 12th October 2024@14:30 hrs at Tuirial River.(Copy enclosed at **Annexure-III** (f)).

2. ASSESSMENT OF WATER QUALITY

As mandated by Revised Guidelines on Idol Immersion, Mizoram Pollution Control Board carried out assessment of water quality in the Tuirial river where Idols was intended to be immersed by Headquarters Project Pushpak, Aizawl, Mizoram and 2nd Assam Rifles, Aizawl, Mizoram on 3rd September 2024 and 17th September 2024 (Pre and during idol immersion for Ganesh Puja 2024), 3rd October 2024, 12th October 2024 and 14th October 2024 (pre, during and post idol immersion for Durga Puja 2024). The analysis result as per the prescribed format is enclosed at **Annexure-IV**.

3. OBSERVATION/REMARKS:

- Headquarters Project Pushpak, Mizoram and 2nd Assam Rifles unit, Aizawl, Mizoram practiced Idol immersion in Tuirial river for celebration of Ganesh Puja and Dusshera 2024.
- It was confirmed that most of the idols used in Ganesh Puja and Dusshera celebration 2024 were made of, traditional clay, bamboo, flowers etc which were all bio-degradable and easily decomposed in water.
- There was no significant change in water qualities due to immersion of the idols during Ganesh Puja and Dusshera as the Idols immersed in water bodies are of eco-friendly idols with herbal colours/ biodegradable dyes as proven by the analysis results indicated above.


