CIRCULAR ON PROCEDURE FOR PUBLIC HEARING

Whereas, Pollution Control Boards/Pollution Control Committees are the Nodal agencies designated by MoEF&CC for conducting of the Public Hearings, in the cases related to Environmental Clearance, where public hearing is an essential component, under EIA Notification, 2006.

Now, therefore, as per the resolution passed by the 62nd Meeting of Mizoram Pollution Control Board held on 19th December, 2024 and in supersession of the previous Notification issued vide Memo.No.F.66066/Gen/9/91-MPCB/34 dated 3rd April, 2009, the Mizoram Pollution Control Board hereby revised charges for conducting Public Hearing on the basis of capital investment (land, building, plant, works & machinery) under the EIA Notification, 2006 and its amendment as under:

Sl.No.	Total project cost	Amount payable (Rs in lakhs)
1	Upto Rs.50 lakh	0.25 Lakhs
2	Above 50 laks to 1 Crore	0.5 Lakhs
3	Above Rs.1 crore and upto Rs.5 crore	1 Lakhs
4	Above Rs.5 crore and upto Rs.10 crore	2 Lakhs
5	Above Rs.10 crore and upto Rs.25 crore	4 Lakhs
6	Above Rs.25 crore and upto Rs.100 crore	6 Lakhs
7	Above Rs.100 crore	10 Lakhs

Procedures and terms laid down from time to time by the Ministry of Environment, Forest & Climate Change in respect of EIA Notification, 2006 shall be followed.

These charges are levied to cover the expenditure on account of Public Notes to be issued in print and electronic media and services provided by Mizoram Pollution Control Board. The charges are required to be paid by the Project Proponent to the Mizoram Pollution Control Board in favor of Member Secretary, Mizoram Pollution Control Board. These should be paid at the time of submission of set of documents related to the Projects.

The project proponent shall make physical arrangement of the public hearing at the time and place as notified by Mizoram Pollution Control Board. Expenditure incurred on the day of public hearing will be borne by the project proponent.


